Textual Information()

1. Spicebolls Investments Limited (Promoter Group) disposed off its entire shareholding aggregating to 83,591 Equity Shares in open market in December, 2022. Spicebolls Investments Limited is shown in the Promoter Group Category with NIL Shareholding as it is a constituent of the Promoter Group of the Company.
2. KK Modi Family Trust is shown in the Promoter Group category with current Shareholding as NIL. It is a Constituent of the Promoter Group of the Company.
3. KEDARNATH MODI (TRUSTEE) MODI SPG.& WVG MILLS CO. LTD. (HEADOFFICE) EMPLOYEES WELFARE TRUST- 45,000 Equity shares held by the Trust were transferred to the IEPF Authority in December, 2022 in accordance with the IEPF Rules. The Trust is shown in the Promoter Group Category with currently NIL Shareholding. It is a constituent of the Promoter Group of the Company.
4. Upasana Investment Pvt Ltd disposed off its entire shareholding aggregating to 450 Equity Shares in Open Market during the quarter ended 30th September, 2023. Upasana Investment Pvt Ltd is shown in the Promoter Group Category with NIL Shareholding as it is a constituent of the Promoter Group of the Company.

Textual Information()

Foreign Ownership approved limits break-up is as under:

i. Foreign Direct Investment (FDI): 25.10% -

Please note that as per Foreign Exchange Management (Non-debt Instruments) Rules, 2019 (Rules), FDI is prohibited in the Company, as it is primarily engaged into manufacturing of cigarettes. Further, the Company has been operating since 1936 and one of the Promoters of the Company, being Foreign Body Corporate, holds 25.1% equity share capital of the Company, in terms of relevant permissions obtained, prior to the said prohibition in FDI coming into place.

ii. Foreign Portfolio Investment (FPI): 24.00% - As per the Rules, the aggregate limit is 24%.

iii. Non-Resident Indian (NRI) or Overseas Citizen of India (OCI) on repatriation basis: 10.00% - As per the Rules, the total holdings of all NRIs and OCIs, put together, shall not exceed 10% of the total paid up equity capital. The aggregate ceiling may be raised to 24% if special resolution is passed. Please note that the Company has not passed any special resolution, hence the limits continue to be 10%.
